There is a need to change the CRL path of the TR-Grid CA
Next CA certificate update.

- Change Identity vetting with e-Government systems:
 - ▶ IGTF Level of Authentication Assurance V1.1-2016, Section 3.1
 - «be validated using notary-public attestations and/or official government data sources and supported by remote live video conversation;»
 - It is possible to check the status of a researcher at any time.
 - Not need to store any identity card after f-2-f identity vetting.
- These updates will be done at the end of April, 2021 in CP/CPS document.


